**WHAT YOU NEED TO KNOW:**

THE CUSTOMER IS RESPONSIBLE FOR THE MAINTENANCE OF ALL GAS PIPING FROM THE CURB STOP TO ALL GAS APPLIANCES. BURIED GAS PIPING WHICH IS NOT MAINTAINED MAY BE SUBJECT TO THE POTENTIAL HAZARDS OF CORROSION AND LEAKAGE. FOR YOUR SAFETY, ALL BURIED PIPING SHOULD BE PERIODICALLY INSPECTED FOR LEAKS. IF THE BURIED PIPING IS METALLIC, IT SHOULD BE PERIODICALLY INSPECTED FOR CORROSION. IF AN UNSAFE CONDITION IS FOUND, THE GAS PIPING WILL NEED TO BE PROMPTLY REPAIRED. WHEN DIGGING NEAR GAS PIPING, THE PIPING SHOULD BE LOCATED IN ADVANCE AND DIGGING DONE BY HAND. IF ACCOUNT BECOMES DELINQUENT THE COLLECTION FEES BECOME THE RESPONSIBILITY OF THE CUSTOMER.
